Preamble

2. Customer account / registration data / personal data

If you provide your name, address and other contact details during registration, it is your voluntary decision to provide this information to Yannick Andrea GmbH in order to use the services offered by the online Photo Archive of Yannick Andrea GmbH. This data is collected and stored exclusively for pre-contractual services, for the fulfilment of the contract, for ordering or for the purpose of customer care (e.g. an overview of your previous shopping baskets, orders).

After our released registration we then save the IP address and the date of your registration and time and with every login, so that your data can be restored in case of questions, possible system failures and possible errors. This data will not be passed on to third parties.

You can revoke the consent given to us to open and maintain your customer account at any time with effect. To do so, you only need to inform us of your revocation.

The data collected in this respect will be deleted as soon as the processing is no longer necessary. However, we must observe tax and legal retention periods.

3. Cookies

You can prevent and or restrict the installation of cookies by adjusting your Internet browser settings. You can also delete already stored cookies at any time. However, the steps and measures required for this depend on the Internet browser you are using. 4. Contract implementation

The data transmitted by you for the use of our range of goods and/or services will be processed by us for the purpose of processing the contract and is required in this respect. Conclusion and processing of the contract are not possible without providing your data.

For technical reasons, in particular to ensure a secure and stable online image archive, data is transmitted to us or to our web space provider by your Internet browser.

These so-called server log files are used to record, among other things, the type and version of your Internet browser, the operating system, the website from which you have switched to our online image archive (referrer URL), the website(s) of our online image archive that you visit, the date and time of the respective access, and the IP address of the Internet connection from which the use of our online image archive takes place.

This data is temporarily stored, but not together with other data about you.

The data will be deleted after seven days at the latest, unless further storage is required for evidence purposes. Otherwise, the data is completely or partially excluded from deletion until the final clarification of an incident.

7. Your rights as a person affected by the data processing

The collected personal data is only used to be able to use the offer of the online Photo Archive of Yannick Andrea GmbH.

You can view, change or delete the data you have entered at any time by logging in. You can obtain information on the use of your data from the data controller of Yannick Andrea GmbH at any time. Your data will be treated confidentially and will not be passed on to third parties, unless ordered by a court of law.
